This Authorization shall remain in effect until: TICF and the financial institution listed in "Bank Details" section above have received written notification from Customer of its revocation in such a manner and time as to give TICF and the financial institution a reasonable opportunity to act upon it or TICF cancels the debits as set forth below. Customer understands and agrees that TICF may cancel the Electronic Debits on the Customer's Designated Account at any time, including if an Electronic Debit is denied payment by Customer's financial institution. Customer understands that it remains responsible for making the payments due under the terms of the TICF Agreements by another means if this Authorization or any Electronic Debit in whole or in part. Customer agrees to be bound by applicable law and the National Automated Clearinghouse Rules as those laws and rules may be amended from time to time.
